- 2 Purchase SofLens® contact lenses from **January 1, 2009 – December 31, 2009**. Product purchase must be made within 90 days of eye exam. Circle the eligible purchase on your receipt or invoice.
- 3 Visit [www.bausch.com/rebates](http://www.bausch.com/rebates) and input this single-use **PERSONAL CODE** to complete the offer form online. Limit 1 rebate per personal code. Complete all information requested online accurately.

## PERSONAL CODE:

- 4 Remove the **original UPC codes** from the **SofLens** boxes. For the \$50 rebate, remove 8 UPC codes from the SofLens® Toric, SofLens® Multi-Focal, or SofLens® daily disposables boxes (SofLens®38 is not eligible for the 8 box \$50 offer). For the \$30 rebate, remove 4 UPC codes from the SofLens® Toric, SofLens® Multi-Focal, or SofLens® daily disposables boxes or **8 UPC codes from the SofLens®38 boxes**. See example to the right.
